October 14th and 15th ,2017

The Bay Path 600 Round is a Star FITA Tournament. The tournament is on Saturday at 10:00 am, 1:00 pm, or 4:00 pm or Sunday at 10:00 am or 1:00 pm.

The tournament is an Indoor Round and consists of a 600 round (20 ends of 3 arrows) within a two-minute time period per end.

All competitors will shoot at a 40 cm FITA multi-color face or a triangular 3-spot face at 18 meters. Inner-10 ring will be in effect for all Compound divisions and classes. The outer 10-ring will be in effect for all classes in FITA Olympic Recurve, Longbow, Traditional Recurve, and FITA Barebow.

FITA Constitution and Rules will be strictly observed for competitors in the FITA Olympic Recurve, FITA Compound and FITA Barebow divisions. Traditional Recurve and Longbow divisions follow USA Archery Traditional Rules. All competitors must follow the **USA Archery Dress Code**.

All competitors must be members of USA Archery. NFAA Member can get a free USA Archery Temporary Membership.

Awards will be presented on Sunday, 10/15/2017, after the 1:00 pm line.
